

- 1. Call to order by President; official opening of the Seventeenth Session The President called the meeting to order on July 23, 2001, at 7:15 p.m. and officially opened the Seventeenth Session of the General Assembly of the Fédération internationale des associations vexillologiques.

3. Roll call of delegates; recognition of quorum by Secretary-General; declaration by President that the Seventeenth Session of the General Assembly is constituted

The Secretary-General called the roll as follows:

Members present (32): AAV; ACV; BDA; CFA; CEBED; CISV; DGF; FDC; FI; FRC; FRCSL; FSA; CIDEC; GWAV; HAVSOM; KVV; MZT (formerly ZI); NFF; NVvV; NEVA; NZFA; NF; NAVA; SSV; SEV; SVB; SAVA; TWMF; USFF: VSHS: VK; and WVRI.

Members absent (10): CFZ (Associate Member); CBFA; HS; HVK; MBV (Associate Member); PH; PTW; SRV; SFV: and UHT.

Officers present (3): Michel R. Lupant, President; Charles A. Spain, Jr., Secretary-General; and Graham M.P. Bartram, Secretary-General for Congresses.

The Secretary-General determined that 32 of the 40 Full Members were present, which satisfied the constitutional requirement that delegates of at least half of the Full Members be present. The Secretary-General recognized the presence of a quorum, and the President declared that the Seventeenth Session of the General Assembly was properly constituted.

- **4. Appointment by President of tellers to count votes** The President appointed José Alegria and Dov Gutterman as tellers to count votes. Zeljko Heimer replaced José Alegria before the vote on item 14.
- 5. Approval of the minutes of the Sixteenth Session of the General Assembly held July 29 and 30, 1999 in Victoria, British Columbia, Canada Moved by the Secretary-General, seconded by the Secretary-General for Congresses, "That the minutes of the Sixteenth Session of the General Assembly, as published in *Info-FIAV* number 15, November 2000, be approved with the following four amendments: (1) page 9, line 9, change from '(a)' to '(b)'; (2) page 11, line 42, change from 'NS' to 'NF'; (3) page 25, line 27, change from 'award' to 'awards'; and (4) page 25, line 44, change from 'Jiří Tenora' to 'Jiří Tenora was nominated'." Adopted by two-thirds majority.

Info-FIAV (ISSN 1560-9979) is published by the Fédération internationale des associations vexillologiques (FIAV) and edited by FIAV Secretary-General Charles Spain, 504 Branard St., HOUSTON TX 77006-5018, USA, sec.gen@fiav.org. The FIAV Board distributes one copy of Info-FIAV free of charge to each FIAV Member, at the FIAV Board's own expense (approximately US\$5.65 per copy), by mailing or e-mailing a copy to the Member's address on file with the Secretary-General. Info-FIAV is not copyrighted and may be freely reproduced. It is the responsibility of each FIAV Member to copy and internally distribute Info-FIAV as necessary. Individual subscriptions to Info-FIAV are not available.

6. Reports by the Board

(a) President. Michel Lupant—The President paid tribute to all the former Presidents and especially to the late William Crampton. The President noted that it was Dr. Crampton's dream for the Nineteenth International Congress of Vexillology to be held in the United Kingdom to celebrate the bicentennial of the adoption of the current Union Flag. He noted the hard work of the Board and thanked the Secretary-General and the Secretary-General for Congresses for their efforts and collegiality. Among his goals as President has been to publicize FIAV, and in the last two years he has visited 27 countries promoting FIAV and vexillology. Another goal has been to promote vexillology to the youth of the world. He challenged the persons present at the General Assembly session to assist the organizers of the Twentieth International Congress of Vexillology (Stockholm, Sweden 2003) in finding ways to allow interested young vexillologists to attend, even though they lack the money to pay the full Congress registration fee. Finally, the President noted the importance of *Info-FIAV* in coordinating the work of FIAV.

(b) Secretary-General. Charles Spain—Four issues of *Info-FIAV* (numbers 15-18) were produced and mailed in the last biennium. The project to publish in *Info-FIAV* all the minutes of the General Assembly sessions is nearly complete; the minutes for 1975 to 1989 were published in the last biennium, leaving only the 1991 minutes.

The Secretary-General reported that while he was not requesting reimbursement for expenses, those expenses were not insignificant. The four issues of *Info-FIAV* cost US\$1,146.49 (photocopying US\$610.54 [donated; 8,722 pages at US\$0.07 per page] and postage US\$535.95), averaging approximately US\$5.65 for each individual copy mailed to Members. The Internet domain www.fiav.org was re-registered at a cost of US\$70.00. Miscellaneous correspondence cost US\$117.48 and office supplies cost US\$21.60. The total out-of-pocket expenses to the Secretary-General for 1999-2001 were US\$745.03. Due to the high cost of international postage, future publication of *Info-FIAV* will shift to e-mailed Adobe PDF files, which the recipients may print themselves. The FIAV website authorized by the Sixteenth Session of the General Assembly had not been established due to lack of funds. Finally, the Secretary-General thanked Jon Radel for his generosity in hosting the e-mail addresses for the FIAV Officers.

(c) Secretary-General for Congresses. Graham Bartram—The Secretary-General for Congresses thanked those who previously warned him about the difficulties of organizing a Congress. He indicated he now appreciated that advice after working on the Nineteenth International Congress of Vexillology. He indicated he will work closely with the organizers for the Twentieth International Congress of Vexillology (Stockholm, Sweden 2003) and the likely organizers for the Twenty-First International Congress of Vexillology (Valletta, Malta 2005) to give them the benefit of the hard lessons he learned and to help them with their planning.

7. Announcements

(a) Proposals to organize ICV 21 (2005). HAVSOM had previously announced in 1999 its interest to host in Valletta, Malta. No other proposals were made.

(b) Proposals to organize ICV 22 (2007). DGF announced its interest to organize a Congress in Berlin, Germany. NZFA announced its intention to organize a Congress in either Nelson or Christchurch, New Zealand. CIDEC announced its intention to organize a Congress in Buenos Aires, Argentina.

- 9. Report of the standing orders commission (Ralph Kelly (chair), Scot Guenter, and Charles Spain)

REPORT OF THE 1999-2001 FIAV STANDING ORDERS COMMISSION

On behalf of Scot Guenter, Charles Spain, and myself, I am pleased to provide the report of the Standing Orders Commission.

At the Sixteenth Session of the General Assembly in Victoria, the Standing Orders Commission reported on a review of the appropriateness of the General Assembly using *Bourinot's Rules of Order* (ISSN 0-7710-8336-X), and a motion was passed to continue the use of these rules on a temporary basis. Incorporated in the report was a set of detailed rules for the conduct of General Assembly sessions which applied the general framework of *Bourinot's Rules of Order* and modified those rules to accommodate the FIAV Constitution and the traditional format of General Assembly sessions. This report was circulated as part of the minutes of the Sixteenth Session of the General Assembly and published in *Info-FIAV* number 15.

The Commission continues to support the use of *Bourinot's Rules of Order* as modified to accommodate the FIAV Constitution, and the Commission recommends that the General Assembly adopt *Bourinot's Rules of Order* for use on a permanent basis.

In addition, the Commission was asked by the FIAV Board to consider the appropriateness of amending the FIAV Constitution to simplify voting on procedural matters by requiring only a simple majority, rather than the current two-thirds majority required for all motions other than those related to the election of officers and amendments to the Constitution. It is the Commission's view that the constitutional change would be appropriate and entirely consistent with the normal operation of Bourinot's Rules of Order and similar rules for the conduct of meetings.

10. Report on ICV 20 (July 28 to August 1, 2003, Stockholm, Sweden) NF announced the dates and location of the Twentieth International Congress of Vexillology.

11. Consideration of candidates for membership

- (a) IHW. The Board recommended that IHW be admitted as a Full Member. Moved by WVRI, seconded by CFA, "That IHW be admitted as a Full Member." Adopted by two-thirds majority.
- (b) JAVA. The Board recommended that JAVA be admitted as a Full Member. Moved by NAVA, seconded by FSA, "That JAVA be admitted as a Full Member." Adopted by two-thirds majority.
- (c) VDCN. The President surrendered the chair to the Secretary-General so the President could present the candidature of VDCN. The Board recommended that VDCN be admitted as a Full Member. Moved by NZFA, seconded by USFF, "That VDCN be admitted as a Full Member." Adopted by two-thirds majority. The Secretary-General surrendered the chair back to the President.
 - (d) SVO. No representative was present from SVO, so SVO's application was not considered.
- (e) CSVA. The Board recommended that CSVA be admitted as a Full Member. Moved by KVV, seconded by NFF, "That CSVA be admitted as a Full Member." Adopted by two-thirds majority.
 - (f) HCEHS. No representative was present from HCEHS, so HCEHS's application was not considered.
- (g) SGHAPG. The President surrendered the chair to the Secretary-General so the President could present the candidature of SGHAPG. The Board recommended that SGHAPG be admitted as an Associate Member. The Board recommended associate membership, rather than full membership, because vexillology is not the principle purpose of SGHAPG. Moved by the Secretary-General for Congresses, seconded by USFF, "That SGHAPG be admitted as an Associate Member." Discussion concerning full versus associate membership. Adopted by two-thirds majority. The Secretary-General surrendered the chair back to the President.
- (h) FOTW. The Board recommended that FOTW be admitted as a Full Member. Moved by NEVA, seconded by SAVA, "That FOTW be admitted as a Full Member." Adopted by two-thirds majority.

 (i) VAST. The Board recommended that VAST be admitted as a Full Member. Moved by the
- (i) VAST. The Board recommended that VAST be admitted as a Full Member. Moved by the Secretary-General for Congresses, seconded by SAVA, "That VAST be admitted as a Full Member." Adopted by two-thirds majority.

The President recognized IHW's, JAVA's, VDCN's, CSVA's, SGHAPG's, FOTW's, and VAST's delegates, and they were given seats in the General Assembly. As a result, the number of Full Members present increased from 32 to 38.

- **12**. **Selection of ICV 21 (2005) organizer** Moved by HAVSOM, seconded by SSV, "That HAVSOM organize the Twentieth-First International Congress of Vexillology in Valletta, Malta." Adopted by two-thirds majority.
- **13. Discussion about ICV 22 (2007) organizer** The Secretary-General for Congresses and immediate past Secretary-General for Congresses Bruce Berry agreed to contact the three candidates and request that each present a proposal to the Eighteenth Session of the General Assembly in 2003.
- 14. Consideration of Board's proposed constitutional amendments

Resolution by the FIAV Board

SECTION 1. AMENDMENT OF CONSTITUTION.

(a)

(a) Articles 7, 9, 14, 15, 18, and 25 are amended as follows:

Art.

- [Full membership] Membership in FIAV is open to any association or institution anywhere in the world having as [its principal] a substantial purpose the scientific study of vexillology. [Associate membership in FIAV is open to other associations or institutions anywhere in the world having vexillology as a center of subsidiary interest.]
- (b) The processing of membership applications is the responsibility of the Board. The Board may delegate this responsibility to a person appointed by it for this purpose. The procedure consists of the following:
 - (1) The applicant shall submit a membership application, which must be received by the Board no later than six months before the convening of the next session of the General Assembly.
 - (2) The Board shall consider the application and make a recommendation to the General Assembly relative to the applicant and shall communicate that recommendation to the applicant and to existing Members not later than three months before the convening of the next session of the General Assembly.
 - (3) The Board may recommend acceptance of the applicant as a [Full] Member, [as an Associate Member,] or may recommend rejection of the [application] applicant.
 - (4) The General Assembly at its next session shall vote on the application. An authorized representative of the applicant may appear at the session to represent its case. A rejected applicant has the right to reapply for membership at any later session of the General Assembly.
- (c) The Board and the General Assembly, in making their decisions about an applicant, shall have regard to the following:
 - (1) the existence of a written constitution and its provisions;
 - (2) the vexillological and non-vexillological activities of the applicant, including meetings, publications, and international relations;
 - in the case of an association, the number of its dues-paying members (minimum of five);
 - registration of its members in International Congresses of Vexillology;
 - (5) the length of time it has existed; and
 - (6) the presence of an autochthonous and authorized representative of the applicant at the session of the General Assembly at which there is to be a vote on the application.

Art. 9

At its discretion, the Board may require a Member to furnish evidence of its continued qualification for membership under the terms set forth in article 7. On the basis of this evidence, the Board may make a

recommendation to the General Assembly on the continuation [or modification] of the membership of the association or institution. If the recommendation is made to remove a Member from FIAV [or change its status from full to associate membership], the Member in question must be notified at least three months in advance of the session of the General Assembly at which there is to be a vote on the matter. The Member shall be invited to present its defense before the General Assembly, but shall not participate in the vote on the matter.

- Art. 14
- (a) The General Assembly is composed of the Officers together with a delegate from each of the [Full and Associate] Members. Each delegate must present to the President written credentials from the Member represented. A Member may delegate any or all of its powers in writing to a delegate from any other Member or to an Officer.
- (b) A session of the General Assembly is not constituted unless delegates of at least half of the [Full] Members are present, except as provided for in article 25.
- (c) Each [Full] Member and each Officer is entitled to one vote in the General Assembly.
- Art. 15 Majorities in the General Assembly consist of the following fractions of those [Full] Members present and voting:
 - (a) A simple majority in the election of Officers. If more than two candidates stand for election for an Office and no candidate receives a simple majority, then the candidate with the least votes shall be eliminated from the next ballot, and so on.
 - (b) Two-thirds for ordinary resolutions.
 - (c) Three-quarters for amendments to the Constitution or dissolution of FIAV.
- Art. 18 The General Assembly may be called into an emergency session if extraordinary conditions require this, as determined by the Board, or if three-quarters of the [Full] Members request this of the Board.
- Art. 25
- (a) A motion to dissolve FIAV may be considered only at a session of the General Assembly at which delegates of at least three-quarters of the [Full] Members are present.
- (b) Instead of sending a delegate, a [Full] Member may chose to submit to the President a written, notarized statement expressing that Member's vote in favor of, or in opposition to, the motion to dissolve. A [Full] Member that submits any such statement shall be considered present at the session for the purpose of determining that the session is constituted to consider a motion to dissolve.
- (c) The General Assembly establishes the terms of the dissolution.
- (b) On the adoption of this section, all current Associate Members immediately become Members.
- (c) Comment: To eliminate the distinction between Full and Associate Members. This distinction was originally introduced in 1989, and it has been a topic of heated debate since that time as the General Assembly has voted to admit as Full Members some associations that arguably did not meet the constitutional requirements for full membership. The Board believes this debate has been extremely contentious and unhealthy, and it should be resolved.

SECTION 2. AMENDMENT OF CONSTITUTION.

- (a) Article 15 is amended as follows:
- Art. 15 Majorities in the General Assembly consist of the following fractions of

those Full Members present and voting:

- (a) A simple majority in the election of Officers. If more than two candidates stand for election for an Office and no candidate receives a simple majority, then the candidate with the least votes shall be eliminated from the next ballot, and so on.
- (b) A simple majority for a motion to amend a motion under consideration, to proceed to the next item of business on the agenda, to defer consideration of a motion, to refer a motion to a Commission, to appeal a ruling of the chair, for a record vote, or to adjourn a session of the General Assembly.
- (c) Two-thirds for [ordinary resolutions] all other motions.

[(e)] (d) Three-quarters for amendments to the Constitution or dissolution of FIAV.

(b) Comment: To allow certain specified procedural motions to be decided by a majority vote. The Board believes FIAV should continue to require a super majority vote on all main motions, which bring business before the General Assembly for action. It is fundamentally antidemocratic, however, to require a super majority vote on the types of procedural motions addressed in this proposal. For example, it makes no sense to require a two-thirds vote to adjourn a session of the General Assembly when it is clear that a simple majority of delegates no longer desires to continue deliberating. The Board has discussed this proposal with the Standing Orders Commission, and the Commission recommends that the proposal be adopted.

SECTION 3. AMENDMENT OF CONSTITUTION.

(a) Article 23 is amended as follows:

Art. 23 [The official journal of FIAV is The Flag Bulletin (ISSN 0015-3370). In addition.]

- (a) FIAV shall publish a newsletter concerning its activities at least once a year for the benefit of its Members, which may be freely reproduced. The General Assembly may initiate or authorize other publications.
- (b) The Flag Bulletin (ISSN 0015-3370) is recognized as a journal for the publication of scientific articles in the field of vexillology.
- (c) Comment: To alter the designation of *The Flag Bulletin* from FIAV's "official journal" (adopted in 1989) back to "a journal for the publication of scientific articles in the field of vexillology" (adopted in 1967). The Board wishes to continue FIAV's longstanding recognition of *The Flag Bulletin*, yet make it clear that FIAV does not own or control *The Flag Bulletin*.

SECTION 4. MISCELLANEOUS.

- (a) Severability. Each of sections 1 through 3 of this resolution may be separately considered by the General Assembly, and approved or disapproved individually.
- (b) Font. Additions to the Constitution are indicated by <u>underlining</u> and deletions to the Constitution are indicated by [<u>enclosure in brackets and strikeouts</u>]. If approved, the modified text shall appear in nonunderlined font without the bracketed and struck out text.
- (c) Comments. The comments to sections 1 through 3 of this resolution are provided for explanatory purposes only and do not form part of the proposed amendment.
- (d) Effective date. Each of sections 1 through 3 of this resolution receiving approval shall be immediately effective at the time of its approval.

Moved by the Secretary-General for Congresses, seconded by the Secretary-General, "That the Board's proposed constitutional amendments be adopted." Motion by NAVA, seconded by FRC, "That section 1(b) be amended to read, 'On the adoption of this section, all current Associate Members cease to be Members, and they are invited to reapply for membership." Point of order by FSA that the motion to amend appears to violate article 9 of the FIAV Constitution, which requires at least three months notice to a Member in advance of the General Assembly if there is to be a vote on removing a Member from FIAV. The President ruled that the motion to amend was out of order as it violated article 9 of the FIAV Constitution (both NAVA and FRC publically agreed with this ruling). Regarding section 1, FRC questioned

the advisability of allowing associations and institutions to join FIAV when their interest in vexillology is secondary. SSV noted the ongoing problems the General Assembly has faced on the issue of full versus associate membership and stated that if the amendment was adopted, the General Assembly would have to be willing to refuse membership to applicants that did not demonstrate a substantial interest in vexillology. USFF suggested that the Board should investigate and report to the Eighteenth Session of the General Assembly in 2003 whether there are Members that should be removed from FIAV. There was no discussion about the remaining sections of the motion. SSV's delegate had to leave, which decreased the number of Full Members present 38 to 37. Adopted by three-fourths majority. Pursuant to section 1(b) of the motion, CFZ, MBV, and SGHAPG became voting Members. Accordingly, the number of Members present increased from 37 to 38.

Resolution by the FIAV Board

Resolved by the voting members of the Fédération internationale des associations vexillologiques,

SECTION 1. AMENDMENT OF CODE.

(a) The Flag Information Code is amended as follows:

[The International Federation of Vexillological Associations recognizes the following Flag Information Code and recommends its use to its members, to individual vexillologists, and to publishers and others concerned for flags.]

FLAG INFORMATION CODE

Sec. 1 The Fédération internationale des associations vexillologiques (FIAV) adopts this Flag Information Code and encourages its use by FIAV Members, individual vexillologists, publishers, and others who study flags.

[l. It is clearly understood that use of the Code in no way is indented to substitute for a complete textual exposition of the information to which the symbols of the Code refer.]

- [H:] Sec. 2 The purposes of the Code are:
 - [A-] (a) [Fe] to allow basic information about flags to be recorded and transmitted concisely, accurately, and in a manner which (1) insofar as possible eliminates misunderstandings and [which] (2) is both easy to learn and comprehensible to persons knowing different languages [and easy to learn];
 - [B-] (b) [To] to standardize knowledge of flags in order to facilitate comparative studies of flag characteristics;
 - [G:] (c) [To] to provide a convenient system for researchers, publishers, and others to record, [data for personal use and for] exchange[s], and [publication of] publish information[:]; and
 - [D.] (d) [Fo] to eliminate, insofar as possible, the confusion that [existing] exists in the terminology employed by governments and others [when reference is made] to describe [to different flags and] national flags and their use[s].
- [HI:] Sec. 3 FLAG COLORS
 - [A-] (a) The following [letters are adopted for use to] abbreviations indicate [the] flag colors [of a flag in illustrations]:
 - R (red) 0 (orange) Υ (yellow) ٧ (green) В (blue) Ρ (purple) Ν (black) W (white) G (grey)

M (brown) Au (gold) Ag (silver)

- [B:] (b) Colors other than those listed [shall be written out in full] above are not abbreviated.
- [C:] (c) The following symbols [are adopted for use in illustrations to] indicate approximate color shades [of a flag]:

- (light) -- (very light) + (dark) ++ (very dark)

[D.] (d) The [letters used] <u>use of a color description</u> without [any] <u>a</u> symbol indicates a medium, normal, or unknown shade of the color.

[IV.] <u>Sec.</u> <u>4</u> FLAG PROPORTIONS

[The following system of identification is adopted for use as part of illustrations of flags of all kinds to indicate relative proportions.] Flag proportions are indicated by a ratio. The first figure corresponds to the width of the flag, which is defined as the side normally attached to the pole or staff. The second figure corresponds to the length of the flag. [Thus a] A flag with a width of 3 units and a length of 5 units [shall be] is written either 3:5 or 3x5.

[V.] <u>Sec.</u> <u>5</u> NATIONAL FLAG [TYPOLOGY] <u>USE</u>

[A:] (a) The following [symbol] grid is [adopted for use in illustrations of] used to describe the use or uses of a flag[s] whose primary purpose is to identify nationality rather than some other characteristic (such as the rank of an individual, [er] the existence of a specific government or military institution [or unit], or some other concept):

- [B-] (b) The six areas of the grid indicate[s] the six basic uses of national flags [of nationality, i.e.]: (1) use by private [citizens] individuals and institutions on land[-]; (2) use by [public] nonmilitary governmental institutions on land[-, and]; (3) use by military institutions on land [and the corresponding usages at sea]; (4) use by private individuals and institutions at sea; (5) use by nonmilitary governmental institutions at sea; and (6) use by military institutions at sea. Private, [public] nonmilitary governmental, and military use [are] is indicated from left to right by the three vertical columns; use on land and at sea [are] is indicated [by the] from top [and] to bottom by the two horizontal [columns] rows[, respectively].
- [C-] (c) The grid [is to be] is written or printed in the line of identifying text near [an] the flag illustration [of a flag], together with the [symbol] ratio indicating proportions. The use or uses of the flag [design illustrated for one or more of the six uses shall be] are indicated by placing a point (*) or an × in the appropriate area or areas of the grid [in printed versions and an × in the appropriate area or areas in a hand-written version].
- [D: The following symbol is adopted for use, as appropriate, in illustrations of flags which identify civil

and/or military aircraft and air installations, a point (+) or * in the appropriate vertical column above the top horizontal line indicating the usage:



Sec. 6 The flag information summarized by the Code is not a substitute for a specific textual description of a flag and its use or uses.

[VI:] Sec. 7 [Changes and additions] An amendment to the Code may be adopted only by [a] the FIAV General Assembly [of the International Federation of Vexillological Associations]. [When possible, all such modifications shall]
Before the General Assembly considers an amendment, the amendment should be discussed [fully in advance] by [all participants at] individuals attending the International Congress of Vexillology during which the General Assembly [is] session will be held. FIAV Members [associations] and individual vexillologists are encouraged to [consider desirable modifications] propose amendments based on their [actual] experience in

(b) Comment: To (1) revise and clarify the Flag Information Code in plain English using structure and terminology similar to that used in the FIAV Constitution and (2) eliminate the symbol used to designate flags which identify civil and/or military aircraft and air installations. The symbol used to designate flags which identify civil and/or military aircraft and air installations has never been widely used, if used at all, and the Board believes any use of that symbol would be extremely confusing.

SECTION 2. MISCELLANEOUS.

- (a) Font. Additions to the Code are indicated by <u>underlining</u> and deletions to the Code are indicated by <u>[enclosure in brackets and strikeouts]</u>. If approved, the modified text shall appear in nonunderlined font without the bracketed and struck out text.
- (b) Comments. The comment to section 1 of this resolution is provided for explanatory purposes only and does not form part of the proposed amendment.

16. Consideration of Board's proposal to name persons as "Fellows of the Federation"

using the Code.

Resolution by the FIAV Board

Resolved by the voting members of the Fédération internationale des associations vexillologiques,

- (a) That the Board may, on behalf of FIAV, name as "Fellows of the Federation" persons who have made significant contributions to vexillology and/or have contributed significant service to FIAV or a FIAV Member.
- (b) That the General Assembly, pursuant to article 16(e) of the Constitution, delegates to the Board its authority to name persons as "Laureates of the Federation," with the understanding that this designation shall be made for an outstanding, original contribution to the science of vexillology.

Comment: The Board believes there is a need for greater recognition of people for significant contributions to vexillology and/or significant service to FIAV or a FIAV Member. However, the Board does not believe it is appropriate to use the "Laureate of the Federation" designation for that purpose. In addition, the Board needs the permission of the General Assembly to allow the Board to name "Laureates of the Federation" as has been FIAV's custom since 1991.

Moved by NEVA, seconded by CIDEC, "That the Board's proposal to name persons as 'Fellows of the Federation' be adopted." Adopted by two-thirds majority.

17. Consideration of Board's proposal to allow former FIAV Officers to use their former title with the word "emeritus."

Resolution by the FIAV Board

Resolved by the voting members of the Fédération internationale des associations vexillologiques,

That the former Presidents, Secretaries-General, and Secretaries-General for Congresses be allowed to use, as appropriate, the title President Emeritus, Secretary-General Emeritus, or Secretary-General for Congresses Emeritus.

Comment: The Board believes FIAV should take this modest step to recognize the dedication of its former Board Members.

Moved by the Secretary-General, seconded by the Secretary-General for Congresses, "That the Board's proposal to allow former FIAV Officers to use their former title with the word 'emeritus' be adopted." Motion by the Secretary-General for Congresses, seconded by FRC, "That the motion be amended to read, 'That the former Presidents, Secretaries-General, and Secretaries-General for Congresses be allowed to use, as appropriate, the title President Emeritus or Secretary-General Emeritus." Motion to amend adopted by simple majority. Amended motion adopted by two-thirds majority.

18. Discussion about specific status of publication of certain ICV proceedings

ICV 5 and ICV 9: FRC reported it was still working on printing in *The Flag Bulletin* a list of papers from those two congresses, including citations of those papers that have already been published.

In order to expedite the publication of Congress proceedings, USFF suggested that future Congress organizers insist that papers be submitted in electronic form.

- **19. Consideration of continued use of** *Bourinot's Rules of Order* Moved by the Secretary-General, seconded by the President, "That *Bourinot's Rules of Order* (ISBN 0-7710-8336-X) be adopted for use on a permanent basis." Adopted by two-thirds majority.
- **20. Election of 2001-2003 Board** Moved by VAST, seconded by NAVA, "That the current President, Secretary-General, and Secretary-General for Congresses be re-elected by acclamation." Adopted unanimously.
- 21. Final adjournment of the Seventeenth Session by President With no further business pending, the President noted to considerable applause that the General Assembly completed its work in only one day (the first time since 1979), and at 9:52 p.m. he adjourned the Seventeenth Session of the General Assembly without fixing a time and day for another meeting of the session.

APPENDIX TO THE MINUTES

IAFM AWARD

On July 27, 2001, a committee of three judges jointly appointed by the International Association of Flag Manufacturers and the FIAV Board presented the IAFM Award at the closing banquet of the Nineteenth International Congress of Vexillology. The award is sponsored by the International Association of Flag Manufacturers and is given for the most creative paper delivered at an International Congress of Vexillology. The recipient was Philippe Rault for his paper on Breton flags, "New Flags for an Old Country."

THE VEXILLON AWARD

On July 27, 2001, the FIAV Board presented the Vexillon Award at the closing banquet of the Nineteenth International Congress of Vexillology. The following is the text of FIAV President Michel Lupant's remarks:

At the suggestion of the Flag Society of Australia, FIAV established the Vexillon Award in 1989 to recognize the person or persons who have made the most important contribution to vexillology during the two years preceding the International Congress of Vexillology. Since 1989, the Flag Society of Australia has graciously provided the plaque for the Vexillon, and the FIAV Board has selected the recipient of the Vexillon.

This year FIAV bestows the Vexillon to a person who is a recent convert to vexillology. Commandant Armand Noël du Payrat received the assignment of editing the French Navy's *Album des Pavillons*, and he quickly threw himself wholeheartedly into the world of flags. Commandant Noël du Payrat and his artist, printer, and other staff have produced a splendid revision of one of the oldest flag books, and now the last surviving book of its kind.

The FIAV Board asks Commandant Armand Noël du Payrat to come forward and accept the Vexillon for this outstanding contribution to vexillology.
