Information to support these applications is as follows:

### 1) LITHUANIAN INSTITUTE OF GENEAOLOGY AND HERALDRY (LIGH)

The Lithuanian Institute of Genealogy, Heraldry, and Vexillology (the 'Institute') is a public legal entity that is independent from the governance of governmental and municipal bodies and institutions and rallies under its own auspices persons and entities that support the Institute's goals and objectives.

In pursuing its objects, the Institute coordinates, approves, and registers the benchmarks and designs of coats of arms, armorial flags, flags, armorial insignia, armorial seals of persons and legal entities, which are outside of the scope of regulation of the laws and legislation of the Republic of Lithuania, and issues documents to that effect.

The Institute conducts genealogical studies of persons, families, and relatives, draws, certifies, and registers genealogical diagrams of persons, issues documents of proof of origin.

The Institute stands in close cooperation with scientific establishments, related and international bodies, conducts heraldic, vexillologic, sigillographic, and genealogic research. Moreover, it organises seminars, conferences, lectures, and engages in publishing business.

On 20 October 2021, the Institute became a full member of the International Confederation of Genealogy and Heraldry (*Confédération Internationale de Généalogie et d'Héraldique*, CIGH). The Institutes accession had the approval from the Confederation's General Assembly in Madrid, Spain. Founded in 1971, the International Confederation of Genealogy and Heraldry is an international organisation that unities the world's institutions responsible for conducting genealogic and heraldic research. Right now, this organisation has more than 80 institutions from 43 countries worldwide as its members.

By decision adopted by the International Academy of Genealogy (*Académie Internationale de Généalogie*, AIG) on 13 December 2021, the 13<sup>th</sup> international genealogic colloquium will be taking place in Vilnius, Lithuania, on 7–11 June 2023. International genealogical colloquia take place in different countries of the world on a bi-annual basis. The 2021 colloquium took place in Messina, Italy, and the next one will take place in Vilnius, Lithuania, in 2023, when the capital of Lithuania will be celebrating its 700<sup>th</sup> anniversary.

Founded in Torino, Italy, in 1998, the International Academy of Genealogy unites competent specialists in genealogy from the world over. As of 2021, the head of this organisation has been Maria Loredana Pinotti.

The 13<sup>th</sup> international colloquium of genealogy will be hosted by the Institute and the International Academy of Genealogy.

The members of the Institute are involved in the activities of the International Confederation of Genealogy and Heraldry, the International Academy of Genealogy, and the International Academy of Heraldry.

THE THREE REGISTERS OF THE INSTITUTE: Flags Coats of Arms Origins (Genealogy).

The Register of Flags consists of personal flags, personal armorial flags, nobility flags, and corporate flags.

The Register of Coats of Arms consists of personal coats of arms, nobility coats of arms, religious coats of arms, corporate coats of arms.

The Institute's key events: The Colloquium on Genealogy, Heraldry, and Vexillology The international science conference titled 'The Readings of Albertas Vijūkas-Kojalavičius'

The Institute's publication, *Genealogy, Heraldry, and Vexillology* is available in printed (ISSN 2669-2945) and electronic (ISSN 2669-2953) form. It features scientific articles and reviews on the subject of vexillology, heraldry, and genealogy.

STRUCTURE The General Assembly of Members

The Institute's General Assembly of Members is the supreme managing body. Every member of the Institute has a right to attend and vote at the Assembly.

The Institute has 51 members. The corporate members of the Institute are the Vexillology Academy, the Heraldry Academy, and the Genealogy Academy.

#### The Board

It is a joint managing body of the Institute that manages the Institute's activities between assemblies. The constitution of the Board and the principles of representation are determined and Board members elected for a five-year tenure by the General Assembly of Members, to which the Board reports and is accountable directly. The duration of the term of office of Board members does not have a time limit.

#### The Chairman of the Board

The Board is represented by the Chairman of the Board elected by the Board members. The Chairman organises and supervises the business of the Board.

#### The President

The President is a sole managing body of the Institute elected by the General Assembly of Members. The President acts in the name of the Institute.

#### The Auditor

The financial operations of the Institute are routinely subject to inspection by the Auditor elected by the General Assembly of Members for a tenure of one year. The Auditor can be a legal entity licenced to provide audit services. No member of the Board or executive staff member may be appointed as the Auditor.

#### 第五章 會議

#### **Chapter 1 : General Provisions**

- (1) Nomination: Chinese name is "Hong Kong Flag Scholar" (hereinafter referred to as "the Association") English name: What the Flag?
- (2) Mailing address: Room E, 7th Floor, Block 26, Sun Peak Garden, Tai Po, New Territories, Hong Kong
- (3) Purpose: To promote the interaction of vexillology among the citizens of Hong Kong and the Chinese. On behalf of Hong Kong, exchanges with foreign vexillologists to improve the knowledge of Hong Kong vexillology. Provide the public with knowledge and information on banner studies, and carry forward the experience of banner scholars.

#### **Chapter 2 : Founding Consultant**

- (1) Anyone approved by the executive committee, such as uniform group members, designers, painters, industrialists, scholars, or people who have contributed to the association, can become the founding consultant or consultant of the association.
- (2) Obligation: Provide advice, help promote the purpose of the association and support various activities of the association.
- (3) Rights:

- i) Attend all meetings of the Association as non-voting delegates
- ii) Enjoy all the benefits provided by the Association.

### Chapter 3 : Membership

- (1) Member category:
  - i) Regular members: Those who are interested in studying vexillology and apply to the association for membership, and the membership is approved by the executive committee.
- (2) Member rights:
  - i) The right to move, elect, be elected, vote and recall;
  - ii) Enjoy all the benefits provided by the Association;
  - iii) Attend meetings of the Executive Committee and working groups as non-voting delegates.
- (3) Membership obligations:
  - i) Attend the committee (applicable to members of the executive committee);
  - ii) Manage the various online platforms of the Association;
  - iii) Obey the constitution and obey the resolutions of the general meeting;
  - iv) Promote the purpose of the association and support the activities of the association.
- (4) Membership:
  - If any member of the Association violates the constitution of the Association, damages the reputation of the Association or abuses the name of the Association for any activity, the membership can be revoked after approval by more than half of all members of the Executive Committee;
  - ii) Membership cannot be transferred to others for use;
  - iii) The association will notify the applicant of the result of the application for membership in writing, email, instant messaging or telephone within 14 days.

# **Chapter IV : Organization and Powers**

(1) Organizational structure

- i) This association takes the general assembly as the highest authority structure, and the executive committee is the executive structure during the adjournment of the general assembly.
- ii) The number of members of each executive committee shall be at least 3, and the members shall vote at the annual general meeting. Members who are elected from each other may elect the chairman, vice-chairman, treasurer and other positions (if any). The executive members may increase or decrease the positions in the committee according to the development of the meeting.
- iii) All positions in the Executive Committee of the Association are obligatory. Each term of office is two years, and re-election can be reelected upon expiration, but the positions of chairman and treasurer cannot be re-elected for more than six years. Each committee member shall not concurrently serve as a salaried employee of the Association or receive any remuneration.
- iv) When the chairman is vacant, the vice chairman shall fill in the vacancy. Other vacancies shall be arranged by the committee according to the meeting affairs.
- v) If the number of candidates for the Executive Committee is less than 3, each candidate will be automatically elected. If there are any remaining positions vacant after mutual elections, the relevant positions shall be vacant.
- vi) If the number of members of the executive committee is equal to 3, then each candidate is automatically elected.
- vii) If the number of members is equal to or less than 3, each member will automatically become a member of the Executive Committee.

- (2) The powers of the general meeting
  - i) Approve and modify the chapter;
  - ii) Election of members of the Executive Committee;
  - iii) Review and approve the meeting and financial reports of the executive committee every year.
  - iv) To pass the resolutions necessary to promote the purpose of the association.
- (3) Duties of the Executive Committee
  - i) Execute the resolutions of the general meeting;
  - ii) Handle daily conference affairs;
  - iii) Formulate financial budget;
  - iv) Plan the development of conference affairs;
  - v) Review membership application qualifications;
  - vi) Report the annual business and financial status at the general meeting;
  - vii) Convene a special membership meeting;
  - viii) Bank signature: it must be signed by any two of the following persons, which are the chairman, vice chairman and treasurer.
  - ix) Routine meetings must be negotiated by the chairman and vice-chairmen, and they can be implemented after reaching a consensus.
- (4) Distribution of powers among members of the Executive Committee
  - i) Chairperson: Write, proofread and review articles or content on the various network platforms of the Association. Handle, plan and preside over various meetings on behalf of the Association, approve finances, membership qualifications, and supervise the duties and progress of each committee member, as well as external liaison work. Keep the seal of the meeting and the member list, assist in recording the proposals and submit the annual meeting report.
  - ii) Vice Chairman: Write, proofread, and assist in reviewing articles or content on various network platforms of the Association. Research and formulate the activities, welfare and overall development of the association, and be responsible for all internal and external liaison and activities. It also includes the liaison of the consultants of the association, attending external events on behalf of the association, and assisting the chairman in handling conference affairs. Assist in the preparation and implementation of all service matters, and assist in handling conference affairs and contact members.
  - iii) Treasurer: keep all the cash of the association, record current accounts, formulate budget and submit annual financial report.

### **Chapter V : Meetings**

- (1) Annual General Meeting
  - i) The annual general meeting is held by the chairman every year, and the interval between each annual general meeting shall not exceed 18 months.
  - ii) The meeting date must be notified to members in writing, email, instant messaging or telephone 14 days before the meeting
  - iii) The content and agenda of the annual general meeting, including:
    a) Handle and pass the resolutions proposed by the current executive committee;
    b) Approval of the financial report;
    c) Adopt the work report;
    d) Election of members of the new executive committee;
  - iv) The number of attendees cannot be less than one-tenth of the number of members.
  - v) If the quorum is insufficient for the first time, the meeting will be announced and held again within 30 days from that day, but it is still necessary to notify the members in writing, email, instant messaging or telephone mail seven days in advance. The second time It is a quorum regardless of the number of attendees.

- (2) If necessary, the special general meeting shall be decided by the executive committee or signed by one-tenth of the members in writing. Although the chairman holds the special general meeting within 30 days from the date of receipt of the request, the relevant meeting date shall be notified to members in writing, email, instant messaging or telephone 14 days in advance. The quorum of the special general meeting is the same as that of the annual general meeting.
- (3) Executive Committee
  - i) The executive committee meets at least four times a year, if the chairman thinks it is necessary, it can be held at any time.
  - ii) When the chairman convenes an executive committee meeting, he shall notify all members seven days in advance.
  - iii) The motions of each meeting must be approved by more than half of the attendees. If both parties have the same number of votes when voting, the chairman presiding over the meeting shall vote for a decision.
  - iv) The decision of the executive committee is half of all executive committee members.

### **Chapter VI : Elections**

- (1) The executive committee election shall be held on the day of the annual general meeting. The election work shall be coordinated and monitored by the independent election committee appointed by the executive committee.
- (2) The candidate list and profile must be sent to members in writing, email or instant messaging 7 days before the annual general meeting.
- (3) When the voting is completed, the votes will be collected on the spot and counted under the supervision of a founding consultant or consultant. The one with the most votes is elected. If there is no founding adviser or adviser to monitor the vote, it will be replaced by a member who voluntarily participates in the vote monitoring.
- (4) The elected executive committee members must hold a new executive committee meeting within 14 days after the end of the general meeting, select positions from each other, and notify the members of the results of the mutual election in writing, email, instant messaging or telephone.
- (5) Old members must transfer all their duties within 14 days from the completion of the general meeting.
- (6) The number of full members in the executive committee must be 70% or more. The positions of chairman, vice chairman and treasurer must be performed by regular members.
- (7) When participating in elections with group votes, the Association must observe the following points:
  - i) If the association needs to vote in any election in the name of a group, a primary election must be held within the association in advance. The voting method of the primary election must be the same as that of the formal election, and the winner will be regarded as the candidate or option of the Association's preference.
  - ii) Voters authorized to vote on behalf of the Association must vote for the aforementioned candidates or options, otherwise the authorization shall be terminated immediately.
  - iii) All arrangements for authorized voting must comply with local election laws.

#### Chapter VII : Membership Fees

- (1) Regular members: There is no formal membership dues.
- (2) For those who withdraw from membership automatically or have their membership removed, all donations paid will not be refunded.
- (3) The income and property of the Association, no matter how they are obtained, shall only be used purely to promote the purposes set out in the Association's constitution. The members of the Association shall not share any part of the income and property of the Association.
- (4) The financial year of the Association is from January 1 to December 31 each year.

#### **Chapter VIII : Appendix**

- (1) If the association needs to be dissolved, it must be approved at the general meeting, and only two-thirds of the members attending the general meeting can agree to dissolve. If there are any remaining assets, they will be donated to charitable organizations that are exempt from tax under Section 88 of the Inland Revenue Ordinance for charitable purposes.
- (2) Any amendments to the constitution of the Association must be approved by the General Assembly before being implemented and submitted to the Societies Registry for record.
- (3) General meetings include annual general meetings and special general meetings.
- (4) If there is an over-funding situation in the mid-year financial affairs, the executive member committee must submit the situation to the annual general meeting to determine the handling method.
- (5) The Association must keep sufficient income and expenditure records (including donation receipts), proper accounting accounts and annual financial reports.
- (6) If any executive member of the Association is directly or indirectly interested in a contract with the Association or a contract proposed with the Association in any way, and such interests are critical, the As far as practicable, members must declare the nature of their interests at the earliest executive committee meeting, and they may not vote on relevant matters.

# CONSTITUTION OF THE VEXILLOLOGICAL SOCIETY (SINGAPORE)

#### NAME

1.1 This Society shall be known as the "Vexillological Society (Singapore)", hereinafter referred to as the "Society".

### PLACE OF BUSINESS

2.1 Its place of business shall be at 10 Gopeng Street, #40-05, Singapore 078878, or such other address as may subsequently be decided upon by the Committee and approved by the Registrar of Societies. The Society shall carry out its activities only in places and premises which have the prior written approval from the relevant authorities, where necessary.

### OBJECTS

- 3.1 Its objects are:
  - a) To promote vexillology as the scientific study of the origins, history, symbolism, and use of flags;
  - b) To research the origins, history, symbolism, and use of flags, in particular in Singapore and Southeast Asia;
  - c) To educate members in all aspects of vexillology;
  - d) To cooperate actively with individuals and institutions having similar concerns, in particular with other vexillological associations, agencies, and research centres of whatever type;
    - e) To represent of vexillologists of Singapore on an international level.
- 3.2 In furtherance of the above objects, the Society may organise meetings, seminars, lectures, and similar events and publicise or distribute Vexillological articles and reports to its members and the public.

### MEMBERSHIP QUALIFICATION AND RIGHTS

- 4.1 Membership is open to any person who shares the Society's objects. Persons who are below 18 years of age shall be accepted as members only with the written consent of their parent or guardian.
- 4.2 Only members who are above 21 years of age shall have the right to vote and to hold office in the Society.
- 4.3. Membership shall be non-transferable.

### APPLICATION FOR AND SUSPENSION OF MEMBERSHIP

- 5.1 A person wishing to join the Society should submit her/his particulars to the Secretary on a prescribed form.
- 5.2. The Committee shall have the power to accept or reject any application, or renewal for membership, without assigning any reason.
- 5.3 A copy of the Constitution shall be furnished to every approved member.
- 5.4 The Committee may suspend up to a maximum period of six months or expel a member by a two-thirds (2/3) vote of the Committee if the member has conducted herself/himself by word, act or omission in a manner, which in the opinion of the Committee, is prejudicial to the interests of the Society and/or injurious to its reputation. Such member shall be given the opportunity to present her/his case in person before the Committee.

# ENTRANCE FEES, SUBSCRIPTIONS AND OTHER DUES

- 6.1 There shall be no entrance fee payable for all members.
- 6.2 There shall be no annual or other dues payable by members. The funds of the Society shall be derived from free-will offerings.
- 6.3 Any funds required for special purposes may only be raised from members with the consent of the general meeting of the members.
- 6.4 The income and property of the Society whensoever derived shall be applied towards the promotion of the objects of the Society as set forth in this Constitution and no portion thereof shall be paid or transferred directly or indirectly by way of dividend or bonus or otherwise howsoever by way of profit to the persons who at any time are or have been members of the Society or to any of them or to any person claiming through any of them.

### SUPREME AUTHORITY AND GENERAL MEETINGS

- 7.1 The supreme authority of the Society is vested in a General Meeting of the members.
- 7.2 An Annual General Meeting shall be held within 3 months from the close of its financial year.
- 7.3 At other times, an Extraordinary General Meeting must be called by the President on the request in writing of not less than 25% of the total voting membership or thirty (30) voting members, whichever is the lesser, and may be called at any time by order of the Committee. The notice in writing shall be given to the Secretary setting forth the business that is to be transacted. The Extraordinary General Meeting shall be convened within two (2) months from receiving this request to convene the Extraordinary General Meeting.
- 7.4 If the Committee does not within two (2) months after the date of the receipt of the written request proceed to convene an Extraordinary General Meeting, the members who requested for the Extraordinary General Meeting shall convene the Extraordinary General Meeting by giving ten (10) days' notice to voting members setting forth the business to be transacted and simultaneously distributing the agenda through the Society's digital newsletter, or through an email broadcast addressed to all voting members of the Society.
- 7.5 At least two (2) weeks' notice shall be given of an Annual General Meeting and at least ten (10) days' notice of an Extraordinary General Meeting. Notice of meeting stating the date, time and place of meeting shall be sent by the Secretary to all voting members. The particulars of the agenda shall be posted on the Society's digital newsletter, or sent by email to all voting members, four (4) days in advance of the meeting.
- 7.6 Unless otherwise stated in this Constitution, voting by proxy is allowed at all general meetings.
- 7.7 The following points will be considered at the Annual General Meeting:
  - a) The previous financial year's accounts and annual report of the Committee.
  - b) Where applicable, the election of office-bearers and Honorary Auditors for the following term.
  - c) Any member who wishes to place an item on the agenda of a General Meeting may do so provided he gives notice to the Secretary one (1) week before the meeting is due to be held.
- 7.8 At least 25% of the total voting membership or thirty (30) voting members, whichever is the lesser, present at a General Meeting shall form a quorum. Proxies shall not be constituted as part of the quorum.
- 7.9 In the event of there being no quorum at the commencement of a General Meeting, the meeting shall be adjourned for half an hour and should the number then present be insufficient to form a quorum, those present shall be considered a quorum, but they shall have no power to amend any part of the existing Constitution.

# MANAGEMENT AND COMMITTEE

- 8.1 The administration of the Society shall be entrusted to a Committee consisting of the following to be elected at alternate Annual General Meeting:
  - A President
  - A Secretary
  - A Treasurer
- 8.2 Names for the above offices shall be proposed and seconded at the Annual General Meeting and election will follow on a simple majority vote of the members. All office bearers, except the Treasurer, may be re-elected to the same or related post for a consecutive term of office. The term of office of the Committee is two years.
- 8.3 Election will be either by show of hands or, subject to the agreement of the majority of the voting members present, by a secret ballot. In the event of a tie, a re-vote shall be taken and if it still results in a tie, a lot shall be drawn to determine who shall be the successful candidate unless the contesting candidate(s) withdrew in favour of one of themselves.
- 8.4 A Committee Meeting shall be held at least once every six months after giving seven (7) days notice to Committee Members. The President may call a Committee Meeting at any time by giving five (5) days notice. Majority of the Committee Members must be present for its proceedings to be valid.
- 8.5 Any member of the Committee absenting himself from three (3) meetings consecutively without satisfactory explanations shall be deemed to have withdrawn from the Committee and a successor may be co-opted by the Committee to serve until the next Annual General Meeting. Any changes in the Committee shall be notified to the Registrar of Societies within two (2) weeks of the change.
- 8.6 The duty of the Committee is to organise and supervise the daily activities of the Society. The Committee may not act contrary to the expressed wishes of the General Meeting without prior reference to it and shall always remain subordinate to the General Meetings.
- 8.7 The Committee has power to authorise the expenditure of a sum not exceeding \$500 per month from the Society's funds for the Society's purposes.
- 8.8. A member, other than an office-bearer, who wishes to represent the Society in dealings with the public or with third parties requires the Committee's approval to do so.

### DUTIES OF OFFICE-BEARERS

- 9.1 The President shall chair all General and Committee meetings. She/He shall also represent the Society in its dealings with outside persons or organisation.
- 9.2 The Secretary shall keep all records, except financial, of the Society and shall be responsible for their correctness. She/He will keep minutes of all General and Committee meetings. She/He shall maintain an up-to-date Register of Members at all times.
- 9.3 The Treasurer shall keep all funds and collect and disburse all moneys on behalf of the Society and shall keep an account of all monetary transactions and shall be responsible for their correctness. She/He is authorised to expend up to \$30 per month for petty expenses on behalf of the Society. She/He will not keep more than \$200 in the form of cash and money in excess of this will be deposited in a bank to be named by the Committee. Cheques, etc. for withdrawals from the bank will be signed by the Treasurer and either the President or the Vice-President or the Secretary.

#### AUDIT AND FINANCIAL YEAR

10.1 Two (2) voting members, not being members of the Committee, shall be elected as Honorary Auditors at alternate Annual General Meeting and will hold office for a term of two years only and shall not be re-elected for a consecutive term. The accounts of the Society shall be audited by a firm of Public Accountants and Chartered Accountants if the gross income or expenditure of the Society exceeds \$500,000 in that financial year, in accordance with Section 4 of the Societies Regulations.

10.2 The financial year shall be from 01 August to 31 July.

# TRUSTEES

- 11.1 If the Society at any time acquires any immovable property, such property shall be vested in trustees subject to a declaration of trust.
- 11.2 The trustees of the Society shall:
  - a) Not be more than four (4) and not less than two (2) in number.
  - b) Be elected by a General Meeting of members.

c) Not effect any sale or mortgage of property without the prior approval of the General Meeting of members.

- 11.3 The office of the trustee shall be vacated:
  - a) If the trustee dies or becomes a lunatic or of unsound mind.

b) If he is absent from the Republic of Singapore for a period of more than one (1) year.

c) If he is guilty of misconduct of such a kind as to render it undesirable that he continues as a trustee.

d) If he submits notice of resignation from his trusteeship.

- 11.4 Notice of any proposal to remove a trustee from his trusteeship or to appoint a new trustee to fill a vacancy must be given by posting it on the notice board in the Society's premises at least two (2) weeks before the General Meeting at which the proposal is to be discussed. The result of such General Meeting shall then be notified to the Registrar of Societies.
- 11.5 The address of each immovable property, name of each trustee and any subsequent change must be notified to the Registrar of Societies.

### VISITORS AND GUESTS

12.1 Visitors and guests may be admitted to join activities of the Society but they shall not be admitted into the privileges of the Society. All visitors and guests shall abide by the Society's rules and regulations.

### PROHIBITIONS

- 13.1 Gambling of any kind, excluding the promotion or conduct of a private lottery which has been permitted under the Private Lotteries Act Cap 250, is forbidden on the Society's premises. The introduction of materials for gambling or drug taking and of bad characters into the premises is prohibited.
- 13.2 The funds of the Society shall not be used to pay the fines of members who have been convicted in court of law.
- 13.3 The Society shall not engage in any trade union activity as defined in any written law relating to trade unions for the time being in force in Singapore.
- 13.4 The Society shall not indulge in any political activity or allow its funds and/or premises to be used for political purposes.
- 13.5 The Society shall not hold any lottery, whether confined to its members or not, in the name of the Society or its office-bearers, Committee or members unless with the prior approval of the relevant authorities.
- 13.6 The Society shall not raise funds from the public for whatever purposes without the prior approval in writing of the Assistant Director Operations, Licensing Division, Singapore Police Force and other relevant authorities.

# AMENDMENTS TO CONSTITUTION

14.1 The Society shall not amend its Constitution without the prior approval in writing of the Registrar of Societies. No alteration or addition/deletion to this Constitution shall be passed except at a general meeting and with the consent of two-thirds (2/3) of the voting members present at the General Meeting.

# INTERPRETATION

15.1 In the event of any question or matter pertaining to day-to-day administration which is not expressly provided for in this Constitution, the Committee shall have power to use their own discretion. The decision of the Committee shall be final unless it is reversed at a General Meeting of members.

# DISPUTES

16.1 In the event of any dispute arising amongst members, they shall attempt to resolve the matter at an Extraordinary General Meeting in accordance with this Constitution. Should the members fail to resolve the matter, they may bring the matter to a court of law for settlement.

# CONFIDENTIALITY

- 17.1 Membership information as well as any other personal particulars shall be used solely for the Society's objects and purposes and shall not be used or released for commercial or solicitation purposes or to promote any other interests or businesses. The Society shall produce guidelines or by-laws and take appropriate measures to comply with applicable data protection legislation for the processing of personal data collected from its members, partner organisations, other third parties, and the public in the course of its activities.
- 17.2 The Committee shall appoint among the office-bearers a Data Protection Officer.

# DISSOLUTION

- 18.1 The Society shall not be dissolved, except with the consent of not less than three-fifths (3/5) of the total voting membership of the Society for the time being resident in Singapore expressed, either in person or by proxy, at a General Meeting convened for the purpose.
- 18.2 In the event of the Society being dissolved as provided above, all debts and liabilities legally incurred on behalf of the Society shall be fully discharged, and the remaining funds will be disposed of in such manner as the General Meeting of members may determine or donated to an approved charity or charities in Singapore.
- 18.3 A Certificate of Dissolution shall be given within seven (7) days of the dissolution to the Registrar of ICV

# RULES OF ORDER FOR THE GENERAL ASSEMBLY

At the Seventeenth Session of the General Assembly (July 23, 2001, York), the General Assembly adopted the following motion, "That *Bourinot's Rules of Order* (ISBN 0-7710-8336-X) be adopted for use on a permanent basis." These are published in Info-FIAV number 19, at page 12 (August 2001).

# **CONSTITUTION OF FIAV**

The FIAV provisional council adopted provisional statutes on September 3, 1967. The FIAV statutes were formally adopted on September 7, 1969 and amended on September 29, 1983. The statutes were replaced by the current FIAV Constitution, which was adopted on September 27, 1989. The Constitution has been amended on August 12, 1997, July 29, 1999, July 23, 2001, August 7, 2007, July 14, 2009, and August 8, 2017.

# CONSTITUTION OF THE FÉDÉRATION INTERNATIONALE DES ASSOCIATIONS VEXILLOLOGIQUES

# I. NAME AND PURPOSES

- Art. 1 The name of this association is the Fédération internationale des associations vexillologiques, which is abbreviated as "FIAV."
- Art. 2 FIAV unites those associations and institutions throughout the world whose object is the pursuit of vexillology, which is the creation and development of a body of knowledge about flags of all types, their forms and functions, and of scientific theories and principles based on that knowledge.

Art. 3 FIAV has as its purposes:

- (a) To create a strong bond among those associations and institutions and to encourage and coordinate their work, studies, and research;
- (b) to promote the organization of International Congresses of Vexillology and to lend its support to their organizers;
- (c) to encourage the creation in all countries of associations and institutions dedicated to vexillology; and
- (d) to recognize international standards facilitating the development of these activities.
- Art. 4 FIAV, being strictly scientific, has no commercial ends and renounces any political or religious activity or stand.

#### II. HEADQUARTERS

Art. 5 The administrative headquarters of FIAV are located at the residences of its two Secretaries-General. If necessary, the General Assembly may establish a legal headquarters for FIAV.

#### III. MEMBERSHIP

- Art. 6 An applicant for membership in FIAV:
  - (a) must be an organization of the type expressed in article 2;
  - (b) must be committed to the purposes of FIAV expressed in article 3; and
  - (c) must be constituted in conformity with the laws of the country where it is located.
- Art. 7 (a) Membership in FIAV is open to any association or institution anywhere in the world having as a substantial purpose the scientific study of Vexillology.
  - (b) The processing of membership applications is the responsibility of the Board. The procedure consists of the following:
    - (1) The applicant shall submit a membership application, which must be received by the Board no later than six months before the convening of the next session of the General Assembly.
    - (2) The Board shall consider the application and inform the applicant and Members of its recommendation not later than one month before the convening of the next session of the General Assembly.
    - (3) The Board may recommend acceptance of the applicant as a Member, recommend rejection of the applicant, or make no recommendation.
    - (4) The General Assembly at its next session shall vote on the application. An authorized representative of the applicant must appear at the session to present its case. Unless excused by the General Assembly, the representative must serve an active role in conducting the applicant's affairs. If the applicant is an association, then the representative must also be a member of the association. A rejected applicant has the right to reapply for membership at any later session of the General Assembly.
  - (c) The Board and the General Assembly, in making their decisions about an applicant, shall have regard to the following:

- (1) the existence of a written constitution and its provisions;
- (2) the vexillological and non-vexillological activities of the applicant, including meetings, publications, and international relations;
- (3) in the case of an association, the number of its active members (minimum of five);
- (4) registration of its members or representatives in International Congresses of Vexillology; and
- (5) the length of time it has existed.
- (a) A Member voluntarily resigns if it does not send a delegate to three consecutive regular sessions of the General Assembly. The resignation is effective at the adjournment of the third consecutive regular session.
  - (b) A Member may voluntarily resign by writing to the President. The resignation is effective on the date of its receipt.
  - (c) FIAV cannot reject a Member's voluntary resignation.
- Art. 9 At its discretion, the Board may require a Member to furnish evidence of its continued qualification for membership under the terms set forth in article 7 or to provide a written response to a potential violation of article 11. On the basis of this evidence, the Board may make a recommendation to the General Assembly on the continuation of the membership of the association or institution. If the recommendation is made to remove a Member from FIAV, the Member in question shall be notified at least three months before the convening of the next regular session of the General Assembly. The Member shall be invited to present its defense before the General Assembly and may participate in the vote on the matter.
- Art. 10 Each Member regulates its own affairs in complete freedom, limited only by this Constitution and the laws in effect in the territory where it functions. FIAV may not otherwise limit the rights of Members in this respect.
- Art. 11 Members shall not undertake any activities contrary to the interests of FIAV.
- Art. 12 (a) FIAV may not act on behalf of its Members without their authorization expressed in the General Assembly. Members may not make commitments nor act on behalf of FIAV.
  - (b) Members may not hold international vexillological meetings outside of International Congresses of Vexillology. Notwithstanding this prohibition, a Member holding a vexillological meeting in any year in which no International Congress of Vexillology is held may invite participation by a Member from a contiguous country.
- Art. 13 (a) The General Assembly may name as "Laureates of the Federation" persons who have made outstanding, original contributions to the science of vexillology. The General Assembly may delegate this power to the Board.
  - (b) The General Assembly may name as "Fellows of the Federation" persons who have made significant contributions to vexillology and/or rendered significant service to FIAV or a FIAV Member. The General Assembly may delegate this power to the Board.
  - (c) Except as provided in article 19(d), Laureates and Fellows have no special rights in the General Assembly.

Art. 8

#### IV. THE GENERAL ASSEMBLY

Art. 14 (a) The General Assembly is composed of the Officers together with a delegate from each of the Members. Each delegate shall present to the President written credentials from the Member represented. A Member may delegate any or all of its powers in writing to a delegate from any other Member or to an Officer.

- (b) A session of the General Assembly is not constituted unless delegates of at least half of the Members are present.
- (c) Each Member and each Officer is entitled to one vote in the General Assembly.
- Art. 15 Majorities in the General Assembly consist of the following fractions of those Members and Officers present:
  - (a) A simple majority in the election of Officers or to excuse the absence of an Officer under article 19(d). If more than two candidates stand for election for an Office and no candidate receives a simple majority, then the candidate with the least votes shall be eliminated from the next ballot, and so on.
  - (b) A simple majority for a motion to amend a motion under consideration, to proceed to the next item of business on the agenda, to defer consideration of a motion, to refer a motion to a Commission, to appeal a ruling of the chair, for a record vote, or to adjourn a session of the General Assembly.
  - (c) Two-thirds for all other motions.
  - (d) Three-quarters for amendments to the Constitution or dissolution of FIAV.
- Art. 16 The General Assembly:
  - (a) elects Officers;
  - (b) examines and approves the administration of the Board and the Commissions;
  - (c) examines all questions concerning FIAV and in particular the organization of the International Congresses of Vexillology;
  - (d) interprets the Constitution;
  - (e) names Laureates and Fellows of the Federation pursuant to article 13 and awards such other distinctions as it deems appropriate to persons or institutions who have shown particular merit in the field of vexillology (this power may be delegated to the Board); and
  - (f) establishes such Commissions as it deems necessary and appoints Commissioners.
- Art. 17 The General Assembly holds a regular session every two years during each International Congress of Vexillology. If extraordinary circumstances exist, a special session may be called with the notice specified in article 18 by either the Board or upon written request to the President by at least two-thirds of the Members.
- Art. 18 The Board convenes a session of the General Assembly. The Board shall give notice of
  - (1) the date, time, and location of the session and
  - (2) the agenda, including any membership applications, amendments to the Constitution, or a motion to dissolve FIAV, to all Members, at least three months before the convening of the next session.

# V. ADMINISTRATION

- Art. 19
- (a) The administration of FIAV is entrusted to a Board which acts only by unanimous agreement. The Board is composed of three Officers: the President, the Secretary-General, and the Secretary-General for Congresses.
- (b) The Officers serve a term that commences after the final adjournment of the session of the General Assembly at which they are elected and ends at the final adjournment of the next session at which Officers are elected. The election of Officers shall be on the agenda of each regular session. Consent of the candidates for election is required. The Officers are eligible for re-election.
- (c) The Secretary-General and the Secretary-General for Congresses must reside on different continents. The Secretary-General manages the Permanent Secretariat of FIAV and the Secretary-General for Congresses manages the Permanent Secretariat of the International Congresses of Vexillology. The Board is considered to be in continuous session, conducted by correspondence.
- (d) A vacancy on the Board occurs if an Officer dies, resigns, or lacks mental capacity under the laws where the Officer resides. Absence of an Officer at a session of the General Assembly creates a vacancy on the Board unless excused by the General Assembly. The resignation of an Officer must be received in writing by another Officer, or if no Officer remains, then by the organizer of the next International Congress of Vexillology. The resignation is effective on the date of its receipt. If a vacancy occurs, the position shall remain vacant and the duties of that Officer shall be performed by the remaining Officers. If no Officer remains to perform the duties of the Board, then the organizer of the next International Congress of Vexillology shall select an interim Secretary General from among the Fellows of the Federation, if available, who shall have the limited authority to take those acts necessary to convene a session of the General Assembly pursuant to article 18 and preside until the General Assembly elects a presiding officer for the remainder of the session. Neither the interim Secretary-General nor the presiding officer serving under this article shall be considered as a voting Officer under articles 14 and 15.

Art. 20 The Board:

- manages the current affairs of FIAV and establishes the duties and obligations of its Officers;
- (b) issues directives which it considers necessary to the success of the activities of FIAV, including the International Congresses of Vexillology;
- (c) establishes such Commissions as it deems necessary and appoints Commissioners;
- (d) convenes sessions of the General Assembly pursuant to article 18;
- (e) represents FIAV in its relations with other national and international institutions; and
- (f) manages membership procedures pursuant to article 7 and encourages vexillological associations and institutions to apply for FIAV membership.
- Art. 21 FIAV's assent to an agreement imposing a binding obligation on FIAV may only be given by a written document signed by all Officers. Current correspondence may be signed by any single Officer.

# VI. LANGUAGES

Art. 22 The General Assembly may designate languages for use in FIAV and the International Congresses of Vexillology, taking into consideration the global nature of vexillology and the related practical and economic concerns, but may not require a delegate, applicant, Officer, or Congress attendee to use any specific language.


# VII. PUBLICATIONS

- Art. 23 (a) FIAV shall publish a newsletter concerning its activities at least once a year for the benefit of its Members, which may be freely reproduced. The General Assembly may initiate or authorize other publications.
  - (b) The Proceedings of the International Congresses of Vexillology shall be published by the Congress organizer(s). Beginning with the Twenty-Ninth International Congress of Vexillology, Congress organizers shall grant a license to FIAV to provide an online version of the Proceedings.

# VIII. SYMBOLS

Art. 24

(a) FIAV's flag is described as follows: "On a blue field, extending horizontally from hoist to fly, two yellow halyards forming two interlaced loops." The color blue is defined as Pantone Matching System U293 and the color yellow is defined as Pantone Matching System U123.



The flag is illustrated as follows:

(b) The General Assembly may adopt Officer flags and other symbols for FIAV.

## IX. DISSOLUTION

Art. 25

- (a) The General Assembly may dissolve FIAV and establish the terms of the dissolution.
- (b) If the General Assembly does not hold a session at which a quorum is present within six years from the final adjournment of the last session at which a quorum was present, then FIAV is dissolved.
